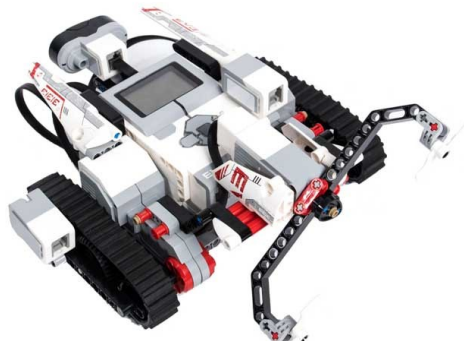
Spring Brings Four New Workshops

CTE Conference ‘Early Bird’ Deadline January 17

The Kansas Annual CTE Conference in Manhattan is open for registration!

Hosted by the Kansas Association of Education Service Agencies (KAESA), the event is the premier conference on Career and Technical Education in Kansas. The pre-conference at the Manhattan Conference Center in the Hilton Garden Inn will be February 3, 2020, with the main conference following on February 4-5.

Be sure to register by January 17, 2020, to take advantage of early bird prices - \$160 for the full conference or \$100 for a single day.

After January 17, prices increase to \$200 and \$150. Breakfast and lunch are included in the February 4 and 5 registration fee.

Health Care, Funding Top Concerns at Legislative Luncheon

Area educators brought priorities directly to state lawmakers at Smoky Hill Education Service Center's 30th annual legislative luncheon on November 14.

School funding, healthcare and statewide economic development topped the areas of concern from educational leaders, who had the opportunity to ask questions of state senators and representatives.

Chris Moddelmog, SHESC Executive Director, said the event has been held every year since the service center was founded in 1990. Much has changed in education since then, but there is at least one constant – the care and concern for education from everyone in the room.

"We all value education," Moddelmog said. "We all value what it can do for our state and citizens."

About 60 people attended the

luncheon. Members of the legislature present were: Katie Sawyer, district director for U.S. Rep. Roger Marshall, R-District 1; Rep. Susan Carlson, R-District 64; Rep. Bill Pannbacker, R-District 106; Sen. Randall Hardy, R-District 24; Rep. Diana Dierks, R-District 71; Rep. Stephen Owens, R-District 74; Rep. Steven Johnson, R-District 108; and Rep. Sydney Carlin, D-District 66.

After brief introductions around the room, legislators gave responses to pre-submitted questions from area educators, followed by an open Q & A. Clear themes emerged, including concerns about increasing health insurance costs, funding for special education, mental health care for students and families and economic development in Kansas.

Rep. Diana Dierks said they, as legislators, need to listen to ideas and input from educators. She went on to



say legislators need help from educators to make sure laws and policies are done at the correct pace and in the right order.

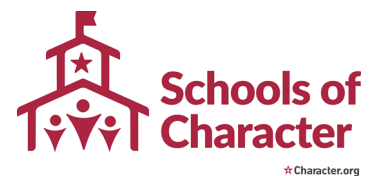
